

BCA Circular – Application for Assessor's Determination Under Part 10A of the COTMA for Construction Contracts

6 July 2022

Dear Members,

BCA would like to remind members that the application period for an Assessor's determination under Part 10A of the COVID-19 (Temporary Measures) Act ("COTMA") will <u>end on 31 August 2022</u>.

Contractors are encouraged to continue to negotiate amicable outcomes between parties. If contracting parties are unable to come to an agreement, <u>contractors may apply for an Assessor to seek a determination to adjust the</u> <u>contract sum for the increase in foreign manpower salary costs</u>, in respect of Work Permit Holders (WPHs), <u>due to COVID-19 for the period between 1</u> <u>October 2020 and 30 June 2022</u>. The application for an Assessor's determination can be made at <u>https://go.gov.sg/cotma10a</u>.

Main contractors involved in eligible public sector construction contracts can request for further adjustment to their contract sum beyond any base adjustment, provided the necessary substantiation is submitted by 31 August 2022. Subcontractors likewise should negotiate with their main contractors for adjustment of contract sum with respect to COTMA Part 10A.

APPLICATION FOR ASSESSOR'S DETERMINATION UNDER PART 10A OF THE COVID-19 (TEMPORARY MEASURES) ACT FOR CONSTRUCTION CONTRACTS IN THE BUILT ENVIRONMENT SECTOR

Objective

This circular reminds the Built Environment ("BE") sector that the application period for an Assessor's determination under Part 10A of the COVID-19 (Temporary Measures) Act ("COTMA") will end on 31 August 2022.

Background

2 COTMA Part 10A was passed in the Parliament on 11 May 2021 to provide an additional legislative relief. This allowed contractors to seek a determination from an Assessor to adjust the contract sum to address the increase in foreign manpower salary costs due to the COVID-19 pandemic. This was to ensure that everyone along the value chain stepped up to co-share the increase in foreign manpower salary costs due to the COVID-19 pandemic.

3 The COTMA relief is meant to be temporary. However, in view of the continued impact of COVID-19 on the BE sector, the Government has extended COTMA Part 10A relief three times from the original end date of 30 September 2021. This has provided firms with additional time and support to negotiate amicable outcomes between parties.

4 In March 2022, COTMA Part 10A was extended for another three months till 30 June 2022 in view that the BE sector was still recovering from the manpower shortage. The last day to apply for a determination from an Assessor to adjust the contract sum for the increase in foreign manpower salary costs has also been extended to 31 August 2022. Since then, the foreign construction manpower inflows have steadily increased to meet the numbers required by the industry. The entry requirements for Construction, Marine Shipyard and Process (CMP) sectors Work Permit Holders (WPHs) have also been progressively eased¹.

5 Contractors are encouraged to continue to negotiate amicable outcomes between parties. If contracting parties are unable to come to an agreement, contractors may apply for an Assessor to seek a determination to adjust the contract sum for the increase in foreign manpower salary costs, in

respect of WPHs, due to COVID-19 for the period between 1 October 2020 and 30 June 2022. *Contractors may submit an application for an Assessor's determination by 31 August 2022.* The application for an Assessor's determination can be made at https://go.gov.sg/cotma10a.

Public Sector Approach

6 <u>Main contractors</u> involved in eligible public sector construction contracts can request for further adjustment to their contract sum <u>beyond</u> any base adjustment², provided the necessary substantiation is submitted by <u>31 August 2022</u>³. <u>Subcontractors</u> likewise should negotiate with their main contractors for adjustment of contract sum with respect to COTMA Part 10A. For avoidance of doubt, main contractors or subcontractors involved in public sector construction contracts may still apply for a Part 10A Assessor's determination if attempts to negotiate with the other party of the contract are unsuccessful.
