



Visit to Hong Kong from 3 to 7 July 2023

Purpose of Visit

Singapore and Hong Kong are among the most dynamic economies in the world. With the re-opening of HK, it will be a great opportunity for counterparts from both countries to connect and exchange views on the market outlook/prospects and emerging trends as well as identify new growth areas, explore business opportunities and establish mutually beneficial collaborative partnerships.

Programmes will include conversations with industry counterparts & senior government officials in Hong Kong to:

- Understand the regulatory regime in Hong Kong and how major developments have been undertaken successfully in partnership between Governments and the private sector and how the public and private sectors can work closer together to strengthen cross-border cooperation;
- Understand the Hong Kong market and explore investment and development opportunities;
- Gain insight into
 - New areas of growth in Hong Kong
 - Hong Kong's Long Term Housing Strategy (LTHS)
 - Hong Kong's land and housing policy & advocacy
 - Property market environments in Hong Kong
 - Housing typologies & trends in Hong Kong
 - Enbloc market & policy in Hong Kong
 - Greater digital connectivity and cross-border trade facilitation
- Site visits to Greater Bay Area (Shenzhen & Guangzhou's Nansha), state-of-art technology project, transport-oriented development project, integrated cross-generation lifestyle project and "Hong Kong-styled International Community" development.


