We are pleased to inform you that REDAS will be organising a visit to Hong Kong from 3rd – 7th July 2023. With the re-opening of HK, the visit will present REDAS members a good opportunity to establish business connections with industry counterparts & senior government officials in Hong Kong as well as explore and forge mutually beneficial partnerships/collaborations.

The visit's programme will include meetings with HK counterparts (like Mr. Adrian Cheng, CEO and Executive Vice-Chairman of New World Development, Dr. Lee Ka Kit, Chairman of Henderson Land Development, Mr. Peter Lam, Chairman of Lai Sun Development Company and Ms. Pansy Catalina Ho, Group Executive Chairman and Managing Director of Shun Tak Holdings Limited, to name a few) as well as Government officials (like Mr. C Y Leung, Former Chief Executive of the Hong Kong SAR (2012-2017), Mr. Paul Chan, Financial Secretary of the Hong Kong Special Administrative Region (HKSAR), and Mr. Ong Siew Gay, Consul General, the Singapore Consulate General in Hong Kong). The trip will also include site visits to a zero-carbon architectural site, K11 MUSEA, Silicon Valley of Culture and Greater Bay Area.
