National 3D Mapping aims to map the entire nation with rapid data capturing technologies to create an accurate, reliable and consistent national 3D map. When city planning scenarios are translated into a 3D 'real world' scenario, we can design, build and develop with clarity and precision. At this session, SLA will provide more insights on how users can utilise the new 3D models in their operation, planning, resource management and policy formulation, and collaboration with research institute to identify buildings with solar energy potential.

2. "Outlook for the Singapore Grade A CBD Office Market in 2024 – From A Tenant's Representative Perspective."

Speaker - Mr Alan Cheong, Executive Director, Research & Consultancy, Savills

After a year of relative quiescence in 2023, the supply of new office developments is expected to resume in a significant way in 2024. Against the backdrop of increasing supply, economic conditions have yet to improve and interest rates expected to remain high for much of the year, the behaviour of tenants in such an environment would be key to determining how office rents may traject in the CBD this year. This presentation will look at the common grounds that most large space tenants have and what industries are performing well in the current economic climate. Arising from this, speaker will weave together the rental outlook for the Grade A CBD office space for the year.
